

2009-2010 Out of School Youth Skills Training Services Program

IPEC, Influencing to Provoke Empowerment for Change, is a multi-faceted faith based non-profit organization that began out of the desire to improve the lives of families and youth in the City of Bessemer. Committed to helping participants meet and exceed their goals and dreams by providing comprehensive training and follow up. Their goal is to significantly reduce economic, social and educational deficiencies through program development.

IPEC, LLC is the first and only Youth Service Provider for Jefferson County's Workforce Investment Board located in the City of Bessemer. They are currently facilitating the 2009-2010 Out of School Youth Skills Training Services Program. The first Medical Certification class in EKG/Cardiac Heart Monitoring ended a few weeks ago with great success. Their second Medical Certification in Phlebotomy has just begun with a class enrollment of 27 individuals.

Due to the success of these programs and a proven track record, IPEC has been awarded a grant to provide and implement the 2009-2010 Out of School Youth Skills Training Services Program through Jefferson County for 100 youth, which provides summer work experience opportunities for youth between the ages of 16 to 21 years old. The mission is to offer an eight-week diverse, high quality program that promotes leadership and youth development through enrichment, educational activities and unique work experiences.

In order to successfully implement this program, the support of local businesses is needed. This support is for summer employment opportunities for graduating students. There are approximately thirty (30) Certified Phlebotomy Technicians and five (5) Certified Cardiac Monitor Technicians. Additionally, there are other students who have the ability to effectively handle light administrative responsibilities. Please note that the grant pays the salary and assumes responsibility for any insurance liabilities. All participants will have an assigned Case Manager that will be responsible for ensuring students are conducting their assigned responsibilities and will periodically meet with the local business for status updates. The tentative start day is June 7th which will be a week of intensive Work Force Readiness Training. On June 14th our students will be report to their designated worksite with July 23rd as their last working date.

Successful implementation of the IPEC programs will fill a void in the community by providing educational and work experience opportunities to our youth. A program of this magnitude can have a significant impact on the lives of our community. The youth, our future, will be exposed to greater opportunities. It's Your Business


